Título/Title	<b>H2020-INT-SOCIETY-2015</b>
Objetivo/Aim	Europe is facing a number of important social, economic and political challenges. It has to rise to the challenges posed by global interdependencies and unprecedented transformations, which strongly affect its capacity to ensure economic growth and more jobs, social stability and a recognized diplomatic position in world matters. However, it suffers from sluggish growth, difficulties to effectively implement structural reforms in favor of innovation and employment and increasing skepticism among citizens, especially young people that Europe may not be well-equipped to get quickly out of the crisis.
