<b>Título/Title</b>	<b>LIFE 2015 CALL FOR PROPOSAL</b>
<b>Objetivo/Aim</b>	The LIFE programme launched environment and climate action sub-programmes underlining its commitment to supporting projects that protect the environment and tackle the impact of climate change.
<b>Entidad convocante/Funding body</b>	<b>EUROPEAN UNION</b>

<b>Plazo /Deadline</b>	Applicants must use only the eProposal tool to create and submit proposals. The deadlines are on the dates indicated below, at <b>16:00 (Brussels local time)</b> . <ul style="list-style-type: none"> <li>• Traditional Projects (Climate Change): <b>15 September 2015</b></li> <li>• Preparatory Projects: <b>30 October 2015</b></li> <li>• Integrated Projects: <b>Phase I, 01 October 2015</b></li> <li>• Technical Assistance Projects: <b>15 September 2015</b></li> <li>• Capacity Building Projects: <b>On a rolling basis until 30 September 2015</b></li> </ul>

**CARACTERÍSTICAS PRINCIPALES ---- MAJOR CHARACTERISTICS**

<b>Dotación /Financial support</b>	For LIFE, the co-financing rate is 60%, except in cases where a project focuses on concrete conservation actions for priority species or habitat, where co-financing can, under certain conditions, increase to 75%. (Capacity building project for Member States are co-financed at 100% of eligible costs.)
<b>Requisitos /Eligibility</b>	Under LIFE, there is no minimum number of beneficiaries set and trans nationality is not a requirement. Transnational projects that bring an added value from the collaboration are encouraged and will receive extra points in their evaluation. Under the Environment subprogram, there are indicative national allocations for the period 2014-2017, to facilitate an even distribution of projects among Member States.

**PRESENTACIÓN DE SOLICITUDES ---- APPLICATION PROCEDURE**

<b>Documentación requerida/ Application materials</b>	Proposals may be submitted by legal persons (entities) registered in the EU. Applicants may fall into three types of beneficiaries: (1) public bodies, (2) private commercial organizations and (3) private non-commercial organizations (including NGOs). Applicants must use the LIFE 2015 application packages (in English only) for the preparation of their proposals. Each application package contains full and detailed explanations with regard to eligibility, procedures, co-financing rates and all other relevant details.
