Title	Call for Proposals JUST/2015/JACC/AG/PROC Justice Programme
Aim	This call for proposals for action grants is based on the 2015 annual work programme of the Justice Programme. It aims to co-fund transnational and or national projects that contribute to the effective and coherent application of EU criminal law in the area of the rights of persons suspected or accused of crime and to the preparation of new EU action, in line with the specific objective to facilitate effective access to justice for all.
Funding body	The funding under this call is based on the co-financing principle by <b>European Commission</b> ; the grant cannot constitute more than 80% of overall eligible project costs. The beneficiaries should ensure that the outstanding balance is covered from sources other than the EU budget (own resources of beneficiaries, contributions by donors, income generated by the project).

Deadline	The deadline for submitting proposals via the PRIAMOS system is 28.10.2015, 12:00 (noon) Central European Time
CARACTERÍSTICAS PRINCIPALES MAJOR CHARACTERISTICS	
Calls	This call for proposals will cover the following activities: - capacity building for professionals; -mutual learning, exchange of good practices, development of working methods which may be transferable to other participating countries; -exchange and provision of information and development of information tools; -facilitating cooperation between competent authorities and agencies, legal practitioners and/or service providers (including multi-disciplinary networks at international, national, regional or local levels); -dissemination and awareness raising activitiesanalytical activities, such as data collection and creation of data bases, surveys, research etc;
Eligibility	Applicant and partners must be legally established in an eligible country. This is not applicable for International organisations.  The EU grant requested cannot be lower than EUR 75 000. There is no upper limit.

Relevance information	This call is managed via <b>PRIAMOS</b> , an on-line system for the submission of applications.  Applicants first need to register and obtain a login and password to access the system. This should be done as soon as a decision is taken to participate in this call.
