ITN will raise excellence and structure research and doctoral training, extending the traditional academic research training setting, incorporating the elements of Open Science and equipping researchers with the right combination of research-related and transferable competences. It will provide enhanced career perspectives in both the academic and non-academic sectors through international, interdisciplinary and intersectoral mobility combined with an innovation-oriented mind-set.

Requisitos /Eligibility:	For ITN European Training Networks (ETN) and ITN European Joint Doctorates (EJD) : the consortium must be composed of at least three beneficiaries located in three different EU Member States of Horizon 2020 associated countries. All three legal entities must be independent of each other. For ITN European Industrial Doctorates (EID) : the consortium must be composed of at least two independent beneficiaries located in two different EU Member States of Horizon 2020 associated countries. Given the nature of EID, at least one beneficiary must be from the academic sector and at least one beneficiary must come from the non-academic sector, primarily enterprises.
