<b>Aim</b>	The overall objective, of the PRIMA programme, is to build research, innovation capacities, and to develop knowledge and common innovative solutions, for agro-food systems, to make them sustainable, and for integrated water provision and management in the Mediterranean area, to make those systems, and that provision and management more climate resilient, efficient, cost-effective and environmentally and socially sustainable, and to contribute to solving water scarcity, food security, nutrition, health, well-being and migration problems upstream.
<b>Funding body</b>	PRIMA consists of European Union Member States, Horizon 2020 Associated Countries and Mediterranean Partner Countries on an equal footing basis (co-ownership, co-management and co-funding) with the Participation of the European Commission. The partnership funding is through a combination of funding from PRIMA Participating States and from the EU thorough Horizon 2020.
