Duración	The programme runs for three years in its first phase, international training phase (outgoing phase), and one more year during the return phase, at any Spanish institution.
Dotación	Up to 70.000 euros/year.
Requisitos	<ul style="list-style-type: none"> <li>➤ Applications will be accepted from cancer researchers who have completed a Doctorate in the last 5 years, or those that can demonstrate at between 4 and 9 years of full-time equivalent experience in cancer research prior to the year of the call for applications.</li> <li>➤ Fellows must not have resided or carried out their career in the country of the outgoing phase host institution for more than 12 months in the 3 years immediately before the programme's year of recruitment.</li> </ul> <p><i>The CRIS Cancer Foundation will sign an agreement with the return host institution, which will sign a contract with the outgoing host institution.</i></p>
