Title	ERC-2023-COG
Aim	The ERC Consolidator Grants are designed to support excellent Principal Investigators at the career stage at which they may still be consolidating their own independent research team or programme. Principal Investigators must demonstrate the ground-breaking nature, ambition and feasibility of their scientific proposal

MAJOR CHARACTERISTICS	
Financial support	Consolidator Grants may be awarded up to a maximum of EUR 2 000 000 for a period of 5 years. The maximum size of the grants is reduced <i>pro rata temporis</i> for projects of a shorter duration. (This does not apply to ongoing projects). Additional funding up to EUR 1 000 000 can be requested in the proposal to cover the following eligible costs when these are necessary to carry out the proposed work: (a) "start-up" costs for Principal Investigators moving to the EU or an Associated Country from elsewhere as a consequence of receiving the ERC grant and/or (b) the purchase of major equipment and/or (c) access to large facilities and/or (d) other major experimental and field work costs, excluding personnel costs. Additional funding is not subject to <i>pro rata temporis</i> reduction for projects of shorter duration. All funding requested is assessed during evaluation.
Eligibility	The Principal Investigators shall have successfully defended their first PhD at least 7 and up to 12 years prior to 1 January 2023. Cut-off dates: PhD awarded from 1 January 2011 to 31 December 2015 (inclusive). The eligibility period can be extended beyond 12 years in certain properly documented circumstances. A competitive Consolidator Grant Principal Investigator must have already shown research independence and evidence of maturity, for example by having produced several important publications as main author or without the participation of their PhD supervisor.
APPLICATION PROCEDURE	
Application materials	All proposals must be complete, readable and accessible. They must be submitted by eligible Principal Investigators before the relevant call deadline The Administrative form Part A (including the Ethics Issues Table and the Budget Section) is available in the submission tool. The Budget table and the justification of the resources are part of this online form Part A (Section 3 - Budget). Part B1, Part B2 and the Host Institution Binding Statement of Support templates are provided in the submission system as word-templates (they should be completed, uploaded and submitted via the submission tool as PDF files).
